

DEMONSTRATION PROGRAM

TERMS & CONDITIONS

- PURPOSE OF THE PROGRAM**
This program is intended only for genuine prospective purchasers. It is not a rental service and is not available for tourism, leisure riding, transportation or holiday use.
- DEMONSTRATION FEE & SECURITY DEPOSIT**
Demonstration fee is 6,000 THB for up to 2 days. Security deposit is 20,000 THB (Cash) and must be paid before collection.
- PURCHASE ELIGIBILITY**
Purchase must be made upon return of the motorcycle to be eligible for the Rent • Try • Buy offer. May only be redeemed at Indian Motorcycle of Hua Hin.
- RIDER ELIGIBILITY**
Rider must be at least 25 years old and hold a valid motorcycle licence recognised in Thailand.
- DISTANCE RESTRICTIONS**
Must not travel more than 150 km from Indian Motorcycle of Hua Hin at any time. Maximum permitted distance is 500 km total over the 2-day demonstration period.
- FUEL POLICY**
Motorcycle will be supplied with a full tank. Must be returned with a full tank. Refuelling charge of 200 THB plus fuel cost applies if not returned full.
- RESPONSIBILITY FOR THE MOTORCYCLE**
Participant accepts full responsibility for the motorcycle from collection until return and must treat it with the same care as their own.
- DAMAGE & REPAIRS**
Participant is responsible for any damage, loss, theft, mechanical damage, third-party damage, and insurance excess. All repair costs must be paid by the participant.
- TOTAL LOSS**
If the motorcycle is stolen, destroyed, written off or declared a total loss while under the participant's responsibility, the participant agrees to pay the full retail purchase price (RRP). The security deposit will be deducted from the amount owing.
- TRAFFIC OFFENCES**
Participant is responsible for all fines, penalties, tolls, parking infringements, camera offences and any other government-issued infringement. Any notices received after return remain the participant's responsibility.
- WEATHER & FLOODING**
Do not ride through floodwaters, on beaches or in conditions likely to cause damage. Any damage resulting from such conditions is your responsibility.
- PERMITTED USE**
For road use only. No racing, racetracks, off-road (unless authorised), commercial use, towing or use by others. No riding under the influence of alcohol or drugs.
- RETURN OF THE MOTORCYCLE**
Must be returned on the agreed date and time, in the same condition as supplied (fair wear and tear excepted), with all keys, documents and accessories, and with a full tank of fuel. Late returns may incur additional charges.
- CANCELLATION / TERMINATION**
Indian Motorcycle of Hua Hin reserves the right to terminate this agreement immediately if the Terms & Conditions are breached, false information is provided, or the motorcycle is used irresponsibly or unlawfully.
- LATE RETURN**
Late returns may incur additional charges and may affect program eligibility.
- PRIVACY**
We retain copies of identification documents, driving licence details solely for this program and insurance purposes.
- GOVERNING LAW**
This agreement shall be governed by the laws of the subject to the jurisdiction of Thai courts.
